- A. Revolvers with non-fluted cylinders are available at no extra charge (see C.). PLEASE NOTE: WITH REGARD TO FLUTED AND NON-FLUTED CYLINDERS, NO EXCHANGES WILL BE ACCEPTED.
- B. Key to basic model numbers, calibers and type:

- D. Special front sight blades as well as recommended procedures are included with each 10", 12" and 15" .357 barrel assembly. Colored plastic inserts are not available for these sight blades.
- E. The bright finish (B) is standard on all Model 15-2 series and need not be specified. It is an option on the Model 14-22 and 14-24 revolvers only and must be so specified when ordering.
