Dan Wesson 414 super mag. This is a stainless steel gun with an 8 inch long barrel chambered in .414 super mag. The gun has been test fired at the factory and most likely not fired by the former owner. There is a slight drag line on the cylinder and that is the only flaw I can see. This comes with 99 pieces of new brass marked 414 E T Gates, a set of Redding loading dies. There is also the instruction manual, the barrel wrench and feeler gauge. This is as good as new. I have what is in the photos only. Shipping is \$20.00; I am an FFL dealer, no local pick-ups. Massachusetts's residents, check with your local dealer to see if this is Mass. compliant, I am NOT a Mass state dealer. Visa, MasterCard, Discover and AmEx accepted at no additional charge.

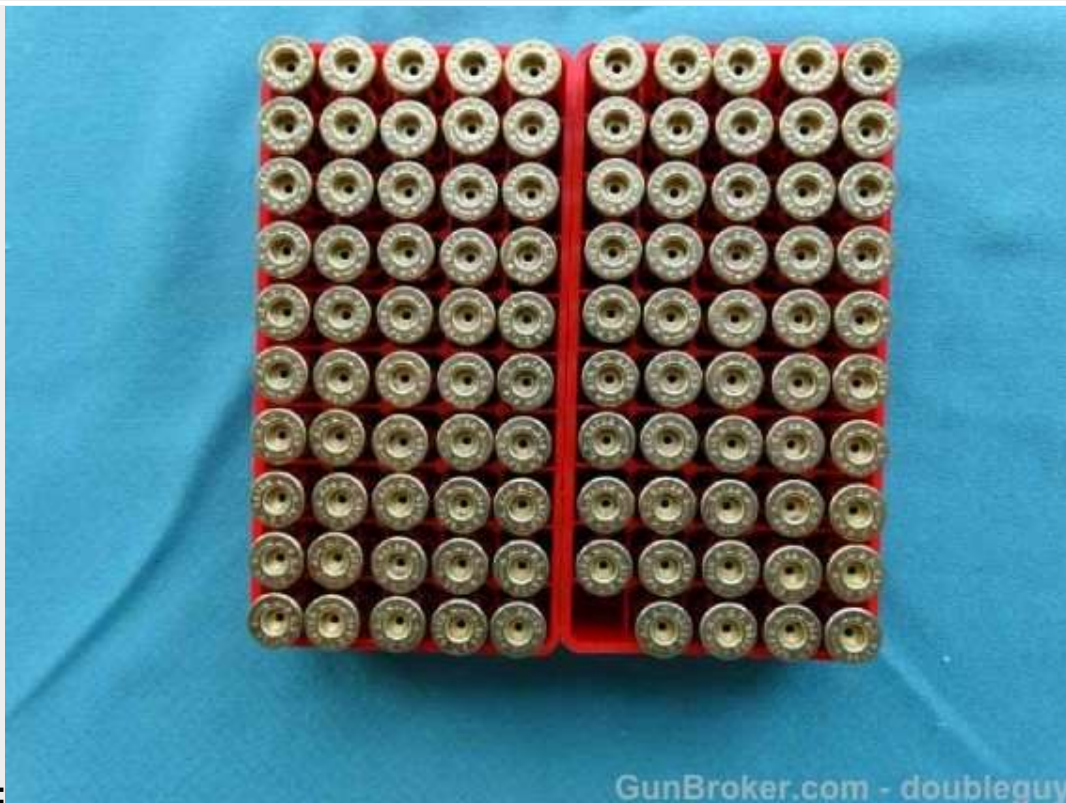
